 - The tender will be launched within March
 - First TFC Casing expected 21 months after KoM
 - All the TFC casings, Thermal Anchors and plates to be provided within 40 months from KoM

- Technical and financial requirements will be requested for the participation

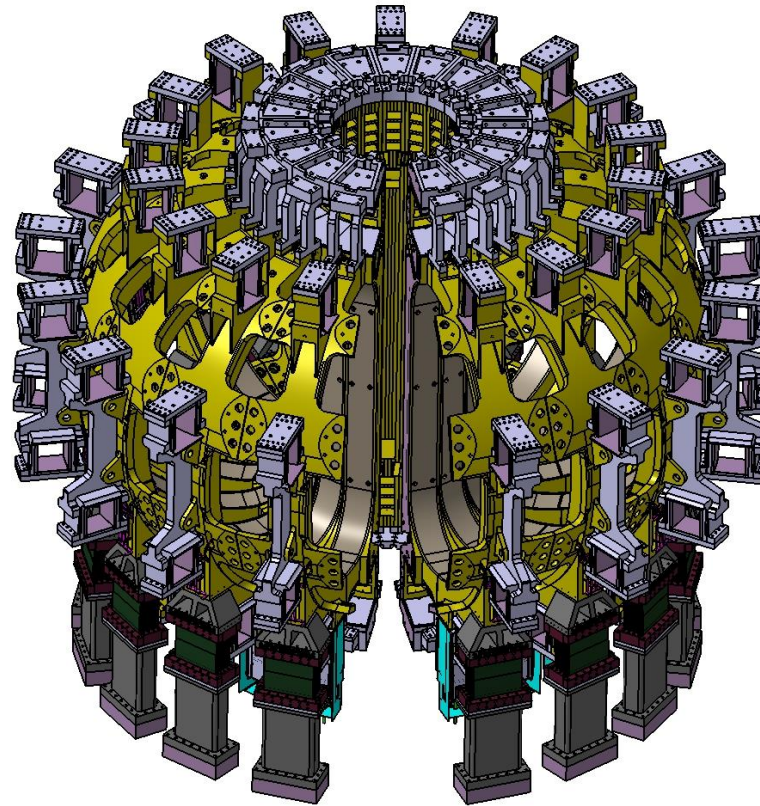

Answer:

the deadline for the offer has not yet been fixed. It will be specified soon in the range of 40-50 days after publication of the tender.

The signature of the contract will come typically after 65 days from the closure of the call for tender (30 days for the award plus 35 days for the signature).

Question

Is there a limit for subcontracting?



Answer:

According to the Italian code of public tenders, no limit is present for the subcontracting. However, DTT intends to limit this possibility excluding a few activities already indicated in the presentation.

May you modify of SoW compare previous tender?

Answer:

The SoW of the previous tender has been modified. The excluded components will be included in a different tender.

We see the Gravity Support has been replaced by Thermal Anchor; is it correct?
